4. On November 14, 2016 Charter agreed to refund subscribers in 32 Massachusetts communities after discussions with the Massachusetts Department of Telecommunications ("DTC"). The agreement resolved the appropriate regulatory treatment of certain fees and rate matters under the jurisdiction of the DTC.

9. Charter incurred losses of \$271 million, \$183 million and \$169 million for the years ending December 31, 2015, 2014 and 2013 respectively. Charter's net losses in part result from large amounts of depreciation and amortization expenses and interest costs. In May of 2016, Charter completed merger transactions with Time Warner Cable, Inc. and Bright House Network. As reported in Charter's quarterly report on form 10-Q for the quarter ended September 30, 2016, filed in November 2016, these transactions have the effect of increasing our annual revenue from \$9.8 billion on an actual basis for 2015 to \$30.2 billion on a pro forma basis. On a pro forma basis, assuming the close of the transactions at the beginning of 2015, Charter reported net income of \$159 million.

10. In our quarterly report on form 10-Q for the quarter ended September 30, 2016 filed in November 2016, we reported current assets of \$2.8 billion and currently liabilities of \$8.6 billion.
